**Benefits of CCC+ Waiver**

- Medical Coverage Through Medicaid
- Personal Care and Respite Assistance
- Help with activities of daily living such as: bathing, dressing, errands, cleaning, cooking, etc

**Things to Keep In Mind**

- You cannot be denied a screening
- The screening should take place in your home with individual present

**Criteria for CCC+ Waiver**

**Financial** – Based on Individuals income, **not the entire family**. If this is a child, they don’t have an income, so this criteria is met!  
**Functional**- Assistance and/or Supervision of Eating, Dressing, Bathing, Toileting, etc.  
**Medical/Nursing Needs** examples are Use of physical and/or chemical restraints, Cannot self assess or monitor, Respiratory therapy, Therapeutic Exercise, and Multiple complex interrelated medical conditions.

**CCC+ Process**

**Medicaid Application**

- Return to Social Services, let them know you applying for Long Term Care Medicaid and would like a CCC+ waiver screening.
- If you are told you will not qualify, as for that in writing.
